The procurement is to be done on the request of head of the departments (Director General Medical Health, Director General Medical Education, and Director General Family Welfare) & for Project Directors.

### **1. GENERAL INSTRUCTIONS:**

- 1.1. The sealed quotations shall be submitted in tender box at UPMSCL: superscription for the "**Annual Maintenance Contract(AMC) for 56 port EPABX machine**" installed at UPMSCL.
- 1.2. Quotation shall be submitted in favour of "**The Managing Director, Uttar Pradesh Medical Supplies Corporation Ltd, Lucknow**".
- 1.3. The last date and time of submission of Quotations shall be 20-05-2026 till 4:00 PM. The quotations obtained at the head office of the Corporation shall be opened at UPMSCL.
- 1.4. The quotation must remain valid for minimum 90 days (3 months) from the date of opening of quotation. UPMSCL, Lucknow reserves the right to accept or reject any/all quotation without assigning any reason whatsoever.

### **2. TERMS & CONDITIONS:**

- 2.1. The Bidder must have successfully completed minimum three (3) year's annual maintenance work of EPABX system in Gov. Organizations/ Private reputed firms. Copy of work order and/or completion certificate shall be attached.
- 2.2. The bidder must have a support office with a help desk facility in their office.
- 2.3. The bidder should be duly registered with the relevant tax authorities as a commercial organization and should have valid relevant certificate like GST, PAN, and TIN etc. The copy of above applicable certificate should be submitted.

## 3. PRICE BID

- 3.1. The price shall be quoted in Indian Rupees only (both in numbers and words. In case of discrepancies between numbers & words, value written in words will be considered valid.
- 3.2. All taxes, duties, levies applicable etc. shall be clearly indicated.
- 3.3. Prices bid quoted must be firm and shall remain constant throughout the period of validity and shall not be subject to any upward modifications, whatsoever.

## 4. BID EVALUATIONS

- 4.1. During Eligibility Criteria Evaluation, bidder's details shall be evaluated with reference to the required Eligibility Criteria as mentioned in this tender document and subsequently the bids of only eligible bidders shall be considered for final evaluation.
- 4.2. The price bids shall be evaluated as under:
  - 4.2.1. The Technically qualified bidder whose evaluated price is found to be lowest (I-1), shall be considered for placement of Work Order for Annual Maintenance Contract for 56 port EPABX machine installed at UPMSCIL.
  - 4.2.2. UPMSCIL reserves the right to accept or reject any or all the proposals without any reason thereof.

## 5. WORK PERIOD

- 5.1. Initially the work order will be issued for 6 month only and shall be further extended up to 6 month on the satisfactory services and performance.
- 5.2. In case of unsatisfactory performance UPMSCIL may automatically terminate the AMC with a prior notice of 15 days. No representation can be accepted in that case.

## 6. PAYMENT TERMS

- 6.1. The Payment shall be made only after submitting the invoice after completion of the work and on quarterly basis.
- 6.2. No advance payment shall be made.
- 6.3. Claim Payment on account of any price variation / escalation shall not be entertained.
- 6.4. Payment will be released after deduction of TDS and other statutory Tax, dues, levies as applicable within 15 days after the receipt of bill. No claim for interest in case of delayed payment will be entertained by the UPMSCIL.
- 6.5. In All case payments under shall be made to the account of the Agency.
- 6.6. In Case of termination of contract the balance payment may be made only for the contracted period.
