Cleaning/507 is also applicable because bidder has already got LOA for 2 no. of schedules in tender no.: UPMSC/SR/Mec. Cleaning/347 and this tender is in continuation of tender no.: UPMSC/SR/Mec. Cleaning/347. Therefore, as per the said clause, the ultimate decision on allotting the schedules to a bidder shall remain the hands of TIA for closure of the tender process. Format-7, i.e. "Financial Capability of the Bidder should be updated &amp; issued on or before bid submission date as mentioned in Tender Document. However, bidder has submitted Format-7 in the Technical Bid which contain the financial capability of the bidder upto 31.03.2019. So submitted document don't reflect the updated financial capability of the bidder.</p> <p>iii. Did not clarify the correct issuance date of Experience Certificate (For Mechanized Housekeeping ) issued by JSS Hospital, Mysuru attached in the technical bid, as the issuing date of said document is 06.10.2022, which shows wrong date (Future Date) of issuing. Clarification has also been asked. No document submitted by bidder. Therefore, this document is considered invalid.</p> <p>In this regard, clarification has also been asked from experience letter issuing hospital i.e. JSS Hospital, Mysuru. No document has been received as clarification.</p>
5	M/s Manjeera Engg & Constn Co Pvt Ltd	Technically Disqualified	<p>Committee has come to know that as per DGMH, UP, Lucknow through their letter vide ref. no.: 11F/2020/3064, dt.: 10.11.2020, issued to firm M/s Manjeera Engineering and Construction Co. Pvt. Ltd., which contains that firm M/s Manjeera Engineering and Construction Co. Pvt. Ltd. has not started and completed the work even after accepting the LOA of the works i.e Mechanized laundry Services. As a result of that, DGMH has taken action (against firm M/s Manjeera Engineering and Construction Co. Pvt. Ltd) to cancel the LOA and the submitted PBG was forfeited .</p> <p>Bidder has also concealed the fact in this tender (tender ref. no.: UPMSCL /SR/Mec. Cleaning/507) that DGMH, GoUP, Lucknow has taken the punitive action (for abandonment of work) against the firm (M/s Manjeera Engg &amp; Constn Co Pvt Ltd) due to non compliance of work (LOA )issued to the firm M/s Manjeera Engg &amp; Constn Co Pvt Ltd).
