Company had supplied "Ranitidine Hydrochloride: 150 mg (Tab) batch no- B210127 (Mfg-07/2021 and Exp-06/2023)", Batch No.- B210193 (Mfg-08/2021 and Exp-07/2023)", Batch No.- B210195 (Mfg-08/2021 and Exp-07/2023) and Batch No.- B210221 (Mfg-08/2021 and Exp-07/2023)" to various Distt Drug warehouse of Uttar Pradesh Medical Supplies Corporation Ltd. against Purchase order no. UP/UP/HQ/21/525/1 (10282103872), dated .06-07-2021. All above Drug batches (Batch No.- B210127, B210193, B210195, B210221) were declared "Not of Standard Quality" by the UPMSCL Empanelled laboratory after drug batch sample testing.

Company Bochem Healthcare Pvt. Ltd. has supplied four "Not of Standard Quality drug batches i.e. Batch No.- B210127, B210193, B210195 and B210221 of the Drug "Ranitidine Hydrochloride: 150 mg Tab to UP Medical Supplies Corporation Ltd. thus Company has violated the tender Clause no.13 (i) of tender No UPMSCL/Drug-67/235 dated 05.09 2020 i.e. "If two batches of any drug supplied by a company/Firm is found "Not of Standard Quality", then the Supplier Company/Firm shall be blacklisted for that particular drug for a period of three year. Hence Company Bochem Healthcare Pvt Ltd was blacklisted by UPMSCL for the drug "Ranitidine Hydrochloride: 150 mg Tab" for three years from

15:03:2022.( Order No. UPMSCL/MD/QC/2022/2165 Dated 15:03:2022).

Company Bochem Healthcare Pvt, Ltd. has filed a petition against above said blacklisting order in the Hon'ble High Court of Judicature at Allahabad, Lucknow Bench, Lucknow on 24.03.2022 (Case; Writ = C. No.- 1780 of 2022 Dated 01.04.2022). In the order dated 04.04.2022 Hon'ble High Court, Lucknow Bench has ordered that "Sample preserved by the opposite parties of the batches subjected to test, be sent to Government Analyst Laboratory within a period of two weeks from the date of presentation of this order and the report may be obtained accordingly not later than a period of two week thereafter. The Impugned decision of Blacklisting shall accordingly be revisited and final decision taken in accordance with law expeditiously and preferably within a period of two weeks from the date of obtaining the report from Government Analyst Laboratory in term of the said report. The Writ petition is accordingly disposed of."

In Compliance to above order of Flonible High Court - Sample of All four drug Batches (Batch No. B210127, B210193, B210195, B210221) of Drug Ranitidine Hydrochloride: 150 mg Tab was collected by the Inspector of Drugs (U.P.) 
Notice to the Company Bochem Healthcare Pvt Ltd was sent on 24.12.2021 (letter no. UPMSCL/MD/QC/2021/1669) regarding supply of Not Of Standard Quality drug "Ranitidine Hydrochloride: 150 mg Tab, Batch No.-B210127 (Mfg-07/2021 and Exp-06/2023)". Another notice to the Compny Bochem Healthcare Pvt Ltd was sent on 25.01.2022 (letter no. UPMSCL/MD/QC/2022/1888) regarding supply of Not Of Standard Quality drug "Ranitidine Hydrochloride: 150 mg Tab, Batch No.-B210193 (Mfg-08/2021 and Exp-07/2023)", Batch No.-B210195 (Mfg-08/2021 and Exp-07/2023) and Batch No.-B210221 (Mfg-08/2021 and Exp-07/2023)".

In the response dated 30.12.2021 & 03.02.2022 which was received to UPMSCL on 13.01.2022 & 03.02.2022 respectively, Company has accepted that they have supplied Batch No.- B210127, B210193, B210195 and B210221 with "minor defects" and they will also take back the above drug batches from corresponding warehouses.

The letter of the Company dated 30.12.2021 & 03.02.2022 was given due consideration but the Company's request to "consider above batches as batches with minor defect and issue a warning letter instead of batch NSQ declaration due to minor defect " is not found satisfactory and justifiable as per tender conditions.

Company Bochem Healthcare Pvt.
