Office Order

Firm Relief Biotech Pvt. Ltd. has rate contract no. 20210023601 (17-March-2021 to 16-March-2023) with UPMSCL for the supply of drug "Sodium Valproate; 200 mg Tablet". Firm has supplied drug "Sodium Valproate; 200 mg Tablet" to various District Drug warehouse of Uttar Pradesh Medical Supplies Corporation Ltd. against Purchase order no. UP/UP/HQ/21/679/1(10282104295), dated 27-07-2021.

Firm Relief Biotech Pvt. Ltd. has supplied drug "Sodium Valproate; 200 mg Tablet" batch No-RT- 210930 (Mfg. date- 09/2021 & Exp.date- 08/2023) to various District Drug warehouse of Uttar Pradesh Medical Supplies Corporation Ltd. against Purchase order no. UP/UP/HQ/21/679/1(10282104295), dated 27-07-2021. Drug sample of said drug batch RT-210930 was collected by Drug Inspector Saharanpur, U.P on dated 08.02.2022 from Saharanpur Drug Warehouse of UPMSCL and it was sent to Government Analyst UP FDA for testing. Above drug batch was declared "Not of Standard Quality" vide certificate no. V/708-22 dated 13.04.2022 for the reason that "The sample does not conform to IP, In respect of Description note". Notice (Ref-UPMSCL/MD/QC/2022/282 Dated- 26.05.2022) for the same was sent to Firm Relief Biotech Pvt. Ltd. on 06.05.2022. Firm has not response of notice dated 26.05.2022 till date.

Another Drug batch no. RT-211027 of Drug "Sodium Valproate; 200 mg Tablet". supplied by the Firm Relief Biotech Pvt. Ltd. against purchase order UP/UP/HQ/21/679/1/(10282104295) dated 27.07.2021 was also declared "Not of Standard Quality" from Government Analyst, UP and notice (Ref- UPMSCL/MD/QC/2022/193 Dated-06.05.2022) for the same was sent to Firm Relief Biotech Pvt. Ltd. on 06.05.2022. Firm has not provided any response of notice dated 06.05.2022 till date.

Firm Relief Biotech Pvt. Ltd. has supplied two "Not of Standard Quality drug batches i.e. Batch No.- RT-210930, RT-211027 of the drug "Sodium Valproate; 200 mg Tablet " to UP Medical Supplies Corporation Ltd. thus Company has violated the tender Clause no.13 (i) of tender no. UPMSCL/Drug-053/212 dated 15.06.2020 i.e. "If two batches of any drug supplied by a company/Firm is found "Not of Standard Quality", then the Supplier Company/Firm shall be blacklisted for that particular drug for a period of three year. Hence Firm Relief Biotech Pvt. Ltd. is, hereby, blacklisted for the drug "Sodium Valproate: 200 mg Tablet " for three years from the date of issue of this office order.
