In the letter dated 02.03.2023, Agron Remedies Pvt. Ltd. has written that they have checked their control sample of both batches and found that drug is of standard quality and ok on all parameters. Company has also mentioned that improper storage of drug may lead to the deterioration in quality. Company has also requested to re-test their sample from UPMSCL empanelled laboratory. Response from company was taken in to consideration but not found justifiable as batches were already tested from UPMSCL empanelled laboratory and after complaint from health facilities testing was done by Government Analyst. All drug batches supplied against PO. No. UP/UP/HQ/21/568/1(10282103956), dated 12-07-2021 were kept on same storage condition and only two batches were declared not of standard quality. In the letter dated 21.03.2023, Company has written that they have recalled the stock of both batches from the warehouses. Company has attached 6 letters written to warehouses (Azamgarh, Bahraich, Siddharth Nagar, Shravasti, Sitapur and Unnao) Incharge Pharmacist of UPMSCL to return the stock lying with concerned warehouses.

With reference to above it is clear that Agron Remedies Pvt. Ltd. has supplied Two "Not Of Standard Quality" drug batches i.e. Batch no. CTZ-36 and CTZ-37 against purchase order no. UP/UP/HQ/21/568/1(10282103956), dated 12-07-2021. "Not Of Standard Quality" reports declared by Government Analyst has neither been cancelled nor annulled by any higher

Hence, Agron Remedies Pvt. Ltd. is, hereby, blacklisted for Drug "Ceftazidime Pentahydrate: IP - 250 mg; dry powder Inj." for three years from the date of issue of this order.
