Office Order

Quest Laboratories Pvt. Ltd has rate contract with UPMSCL for the supply of drug "Ibuprofen 200mg Tab". Quest Laboratories Pvt. Ltd has supplied drug "Ibuprofen: 200mg Tab" Batch (Mfg. date-11/2021 & Exp.date-10/2023) against Purchase order no. UP/UP/HQ/21/1036/2 (10282106105), dated 11-11-2021 and Batch No- T3034 (Mfg. date-04/2022 & Exp.date-03/2024) against Purchase order no. UP/UP/HQ/22/346/2 (10282202430) dated 11.04.2022. to various District Drug warehouses of Uttar Pradesh Medical Supplies Corporation Ltd.

Drug sample of drug Batch No- T3021 was collected by Drug Inspector Ambedkar Nagar, U.P on dated 07.06.2022 from Ambedkar Nagar Drug Warehouse of UPMSCL and it was sent to Government Analyst UP FDA for testing. Above drug batches was declared "Not of Standard Quality" vide certificate no. R/4378-22 dated : 17-11-2022 for the reason that "The sample does not conform to relevant parameter in respect of Description". Notice (UPMSCL/MD/QC/2023/53 dated 17.04.2023) was sent to Quest Laboratories Pvt. Ltd on dated 17.04.2023 regarding supply of "Not Of Standard quality" drug "Ibuprofen : 200mg Tab" Batch No- T3021. Company has not provided any response to notice dated 17.04.2023 till date.

Drug sample of drug Batch No- T3034 was collected by Drug Inspector, Hapur on dated 14.11.2022 from CHC Garh Road, Hapur and it was sent to Government Analyst, Lucknow for testing. Above drug batch- T3034 was declared "Not of Standard Quality" vide certificate no. V/5562-22 dated: 10.02.2023 for the reason that "The sample does not conform to I.P in respect of description". Notice (UPMSCL/MD/QC/2023/855 dated 27.09.2023) was sent to Quest Laboratories Pvt. Ltd on dated 27.09.2023 regarding supply of "Not of Standard quality" drug "Ibuprofen: 200mg Tab" Batch No- T3034. Company has not provided any response to notice dated 27.09.2023 till date.

Again a Notice ref. no. UPMSCL/QC/2023/1134 dated 20.10.2023 regarding "Not of Standard Quality" drug batches T3021 and T3034 of drug Ibuprofen 200mg Tab was sent to firm. Company has not provided any response till date.

With reference to above it is clear that Quest Laboratories Pvt. Ltd. has supplied two "Not Of Standard Quality" drug batches i.e. batches no. T3021 and T3034 against purchase order no. UP/UP/HQ/22/346/2 (102822202430) dated 11.04.2022 and UP/UP/HQ/21/1036/2 (10282106105) dated 11.11.2021. Reports declared "Not of Standard Quality" by Government Analyst has neither been cancelled nor annulled by any higher authority and therefore the analysis report remains conclusive report till date.

Thus Quest Laboratories Pvt. Ltd has violated the conditions of contract clause No. 13 (Debarring & Blacklisting) (i) of tender no. UPMSCL/Drugs-53/212 dated 15.06.2020 i.e. "If two batches of any drug supplied by the firm is found not of standard quality, then the firm shall be blacklisted for that particular drug for the period of 3 (Three) Years" by supplying two

"Not of Standard Quality" drug batches i.e. batch no. T3021 and T3034 of drug "buprofen 200mg Tab" to different district drug Warehouses of Uttar Pradesh Medical Supplies Corporation Limited.

Finally Quest Laboratories Pvt. Ltd has violated conditions of contract of tender clause no. 13 (i). Hence, Quest Laboratories Pvt. Ltd is, hereby, blacklisted for three years for drug "Ibuprofen 200mg Tab" from the date of issue of this order.
