Ltd. has declared batch No- T25212 as "Not of Standard Quality" (Report no. D2023102600150 Dated 20.11.2023). After Testing Bee Pharmo Labs Pvt. Ltd. has declared batch No- T25212 as "Not of Standard Quality" (Report no. D/23/2710/056 Dated 4.11.2023). After three Laboratory test report batch No- T25212 was finally declared "Not of Standard Quality".



With above description it is clear that Quest Laboratories Pvt. Ltd. has supplied two "Not of Standard Quality" Drug batches (Batch No. T25212 and Batch No. T25205) to UPMSCL and thus also violated the Condition of contract ; Clause no. 13 (Debarring & Blacklisting) Sub clause (i) of Tender no. UPMSCL/Drugs-157/533 dated 12.01.2022 i.e. "If two batches of any drug supplied by a Company/firm is found not of standard quality, then the Supplier Company/firm shall be blacklisted for that particular drug for a period of three years". Reports declared "Not of Standard Quality" by Government Laboratory and UPMSCL Empanelled Laboratories has neither been cancelled nor annulled by any higher authority and therefore the Certificate of analysis (Test) report from Government Laboratory and UPMSCL Empanelled Laboratories remains conclusive report till date.

Finally Quest Laboratories Pvt. Ltd has violated conditions of contract of tender clause no. 13 Sub clause (i). Hence, Quest Laboratories Pvt. Ltd is, hereby, blacklisted for three years for drug "B Complex : Vitamin B1 5 Mg Thiamine Hydrochloride, Vitamin B2 5mg Riboflavin, Vitamin B6 2mg Pyridoxine Hydrochloride, Vitamin B3 Nicotinamide 50 Mg, Vitamin B5 Calcium Pantothenate 5 Mg Tablet" from the date of issue of this order.

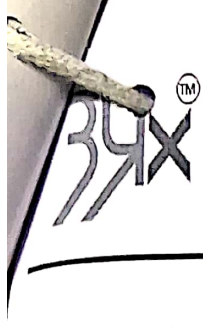


