Quest Laboratories Pvt. Ltd. has supplied batch no. L2941 against Purchase Order no. UP/UP/HQ/23/725/4 (10282304037) Purchase dated 21.03.2023 and UP/UP/HQ/23/910/4 (10282304585) dated 24.04.2023 to various District Drug warehouses of Uttar Pradesh Medical Supplies Corporation Ltd. After supply, Drug Batch No- L2941 was sent to Shree Krishna Analytical Services Pvt. Ltd. (UPMSCL empanelled Laboratory) for testing. After testing, Shree Krishna Analytical Services Pvt. Ltd. has declared batch no- L2941 as "Not of Standard Quality" (Report no. SKF-220623010 Dated 10.07.2023). Furthur batch No- L2941 was sent to 2 Other UPMSCL empanelled Laboratories i.e. Bee Pharmo Labs Pvt. Ltd. and Satiate Research & Anatech Pvt. Ltd. for confirmation. After testing, Bee Pharmo Labs Pvt. Ltd. has declared batch no- L2941 as "Not of Standard Quality" (Report no. D/23/1608/090 Dated 24.08.2023). After testing, Satiate Research & Anatech Pvt. Ltd. has declared batch No- L2941 as "Standard Quality" (Report no. SA/FP-120823/044 Dated 26.09.2023). After three Laboratory test report, batch No.- L2941 was finally declared "Not of Standard Quality".

Quest Laboratories Pvt. Ltd. has also supplied batch no. L2939, Purchase order no. UP/UP/HQ/23/725/4 (10282304037) dated 21.03.2023, and L2950 against Purchase Order no. UP/UP/HQ/23/1100/4 (10282305009) dated 16.05.2023 and UP/UP/HQ/23/1553/3 (10282307532) dated-29.07.2023. to various District Drug warehouses of Uttar Pradesh Medical Supplies Corporation Ltd.

Another Notice (Ref No-UPMSCL/MD/QC/2024/72 dated - 22.04.2024) was sent to Company regarding supply of "Not Of Standard Quality" drug "Paracetamol Syrup 125mg/5ml (60ml bottle with measuring cap)" batch no. L2939 and batch no. L2950 to different District Drug warehouses of Uttar Pradesh Medical Supplies Corporation Ltd. Response provided by an advocate Mr Vedant Srivastava on behalf of Quest Laboratories Pvt. Ltd via letter on dated 14.05.2024 against notice dated 22.04.2024 (Ref No. Ref No-UPMSCL/MD/QC/2024/72) by UPMSCL. Representation given on company's behalf was duly considered but not found correct and justifiable with reference to tender condition and Indian Pharmacopoeia.

Earlier Quest Laboratories Pvt. Ltd has been already blacklisted for five drugs i.e. Tablet Calcium Carbonate With Vitamin D3 1250mg+250 IU (Ref No. UPMSCL/MD/QC/2023/121 Dated -29.04.2023), Tab. Ibuprofen 200 mg Tab (Ref. No. UPMSCL/MD/QC/2023/1198 Dated -03.11.2023), Cefixime Oral Suspension IP 100mg/5ml 30ml bottle" (Ref. No. UPMSCL/MD/QC/2023/1317 Dated -28.11.2023), "Calcium Vitamin D3 Suspension (Each 5ml contains Calcium Carbonate eq. to Elemental Calcium 250mg+Vitamin D3 -125 IU) 200 ml Bottle" (Ref. No.UPMSCL/MD/QC/2024/1689 Dated -14.02.2024)" and "B Complex: Vitamin B1 5 Mg Thiamine Hydrochloride, Vitamin B2 5mg Riboflavin, Vitamin B6 2mg Pyridoxine Hydrochloride, Vitamin B3 Nicotinamide 50 Mg, Vitamin B5 Calcium Pantothenate 5 Mg Tablet* (Ref No. UPMSCL/MD/QC/2023/121 Dated -27.05.2024).

With above description it is clear that Quest Laboratories Pvt. Ltd. has supplied three "Not of Standard Quality" Drug batches (Batch No. L2939, Batch No. L2950 and L2941) to UPMSCL and thus also violated the Condition of contract; Clause no. 13 (Debarring & Blacklisting), Sub clause (i) of Tender no. UPMSCL/Drugs-157/533 dated 12.01.2022 i.e. "If two batches of any drug supplied by a Company/firm is found not of standard quality, then the Supplier Company/firm

shall be blacklisted for that particular drug for a period of three years". Reports declared "Not of Standard Quality" by UPMSCL Empanelled Laboratories has neither been cancelled nor annulled by any higher authority and therefore the Certificate of analysis (Test) report from UPMSCL Empanelled Laboratories remains conclusive report till date.

Finally Quest Laboratories Pvt. Ltd has violated conditions of contract of tender clause no. 13 Sub clause (i). Hence, Quest Laboratories Pvt. Ltd is, hereby, blacklisted for three years for drug "Paracetamol Syrup 125mg/5ml (60ml bottle with measuring cup)" from the date of issue of this order.

UPMSCL/Drugs-157/533 dated 12.01.2022 I.e. "If two batches of any drug supplied by a Company/firm is found not of standard quality, then the Supplier Company/firm
