Reports declared "Not Of Standard Quality" by UPMSCL empanelled Analytical laboratories has neither been cancelled nor annulled by any higher authority and therefore the analysis report remains conclusive report till date.

Thus Quest Laboratories Pvt Ltd has violated the conditions of contract **clause No. 13 (Debarring & Blacklisting) (i)** of tender no. UPMSCL/Drugs-145/520 dated 27.11.2021 and UPMSCL/Drugs-157/533 dated-12.01.2022 i.e. "if two batches of any drug supplied by the company is found not of standard quality, then the company shall be blacklisted for that particular drug for the period of 3 (Three) Years" by supplying 24 "Not of Standard Quality" drug batches to different district drug Warehouses of Uttar Pradesh Medical Supplies Corporation Limited.

Earlier, Quest Laboratories Pvt. Ltd was blacklisted for Drug Calcium Carbonate With Vitamin D3 1250mg+250 IU Tab (Ref. No. UPMSCL/MD/QC/2023/121 dated-29.04.2023), Drug Ibuprofen 200 mg Tab (Ref. no. UPMSCL/MD/QC/2023/1198 dated-03.11.2023) and Drug Cefixime Oral Suspension IP 100mg/5ml 30ml bottle (Ref. no. UPMSCL/MD/QC/2023/1317 dated-28.11.2023).

Finally Quest Laboratories Pvt. Ltd. has violated conditions of contract of tender clause no. 13 (i). Hence, Quest Laboratories Pvt. Ltd. is, hereby, blacklisted for three years for drug "Calcium Vitamin D3 Suspension (Each 5ml contains Calcium Carbonate eq. to Elemental Calcium 250mg+Vitamin D3 -125 IU), 200 ml Bottle)" from the date of issue of this order .

No. UPMSCL/MD/QC/2023/121 dated-29.04.2023), Drug Ibuprofen 200 mg Tab (Ref. no. UPMSCL/MD/QC/2023/1198 dated-03.11.2023) and Drug Cefixime Oral Suspension IP 100mg/5ml 30ml bottle (Ref. no. UPMSCL/MD/QC/2023/1317 dated-28.11.2023).
